The amount of lessons that remain for the year will be communicated to you when the lessons commence. The total fee for the yearly lessons will be divided equally over 12 months. If you decide to cancel lessons before the end of the year the amount of lessons will be recalculated and the invoice readjusted.

Please note that these rates do not include books, eisteddfod fees, extra masterclass fees, or exam fees.

3. Yearly registration fee of R110 is payable with enrolment to book your child's place. This fee includes a homework book, and a gift at the end of the year.

5. Monthly fees must be paid within the first two weeks of each month.
6. Use your child's name and surname as reference.
